Admission Policy

Notice of School Student Non-Discriminatory Policy

San José Sánchez Del Río Catholic School is a parochial school of Our Lady of Good Counsel Catholic Church. All applications for admission will be time stamped in the order received. Families applying for admission will be considered in the order their applications are received. Admission to San José Sánchez Del Río Catholic School is dependent upon a family meeting the Admissions Requirements of the school as stated in the Parent & Student Handbook. These requirements include but are not limited to the following:

- > Families must be willing that their children learn about the Catholic Faith and attend Mass daily, and be supportive of their participation in Faith-based activities.
- > Families must be willing and able to participate in their child's education by giving of their time, talent and treasure.
- > Families must be able to cover tuition costs for their child as determined by the Tuition Schedule located on the SJSDR Catholic School Tuition Fees Policies & Contract.
- > Families must be willing to abide by all San José Sánchez Del Río Catholic School Policies.

Both the family and the school are committed to fostering the educational, spiritual and moral development of the student. This requires a cooperative, collaborative relationship between the school and the family. In the event that this cooperative, collaborative relationship between the school and the family becomes broken, it may be necessary, in the sole discretion of the school Directress, to dis-enroll the student from the school. This would not be considered a disciplinary measure. In that event, the family shall have no further monetary obligations to the school under this contract from the date of the dis-enrollment forward.

Age Requirement for Kindergarten Enrollment: The state of California requires a child to be 5 years of age by September 1st in order to enter a regular kindergarten class. SJSDR Catholic School will be using this date as a guideline as well. However, we feel that there are many indicators of readiness besides the date of birth.
